Tuition Rates 2018–19

Primary Division

Creative Movement I & II

Offered once a week for a monthly tuition of \$60.
The registration fee is \$60.

Pre-Ballet I & II

Offered once a week for a monthly tuition of \$65.
The registration fee is \$65.

Elementary Division

Grades I, II, III & Advanced Grade III

Students are required to take at least two classes per week. The registration fee is \$95.

Advanced Division

Grades IV & V

Students are encouraged to study daily. The registration fee is \$125.

Individual Classes

Adult students unable to attend on a regular basis may pay for individual classes. The cost per class is \$15 for Elementary Division, \$20 for Advanced Division. Classes can be paid for in advance by purchasing a class card. There is a \$35 registration fee.
